## Program Description

The Cornell-Tsinghua MBA/FMBA is a dual degree program offered by Johnson at Cornell University and PBC School of Finance (PBCSF) at Tsinghua University. The program predominantly operates in Beijing at Tsinghua University and is designed to appeal to corporate executives and organizational leaders across China.

The Cornell-Tsinghua MBA/FMBA program is the only program of its kind in the market. This dual-degree MBA program is delivered in English and Chinese (Mandarin) and is offered in partnership with the PBC School of Finance (PBCSF) at Tsinghua University. After two years of part-time study, graduates of the Cornell-Tsinghua MBA/FMBA program will receive an MBA from both Cornell University and Tsinghua University. This program, based in Beijing, accommodates the demanding lifestyles of fast-rising corporate stars and entrepreneurs, allowing students to balance life, work, and study.

Full time status for the program is defined as a minimum of 6 graduate-level credits per term.
